

# PACC BUILDING & AGE POLICIES (10/01/2025)

- All members must scan in and guests must purchase day passes at the front desk.
- Members over the age of 16 may purchase a 24/7 fob to access the PACC outside of staffed hours.
- Cell phone/Photography policy:
  - Phones should be set to 'silent' or 'vibrate' while in the facility
  - Phone conversations should take place in lobby areas only and should not take place via speakerphone
  - Phone use and photography is prohibited in all locker rooms and rest rooms at all times
  - If taking photos in fitness areas you must ensure only those giving permission to be in the photo are in it
- Appropriate clothing and footwear must be worn at all times; shirt and shoes are required except in locker rooms and Aquatics area; Shoes **MUST BE CLEAN!**
- Aquatics accepted materials and apparel is posted in the pool side locker rooms and in the pool area.
- **Parties are not allowed in lobby areas.** you may inquire about party rental rooms
- Help keep our facility clean and RESPECT other patrons and our staff by:
  - Keeping showers to a maximum of 10 minutes
  - Wipe down all machines, mats, weights and other equipment after use
  - Dispose of trash and recycling in designated receptacles
  - Limit perfume/cologne use
  - Keep earbud/headphone volume at a level that does not disrupt others
  - **NO EXTERNAL speakers allowed at any time;** this includes video watching, or conversation via speakerphone
  - Avoid dropping or throwing weights excluding bumper plates
  - Use **appropriate language.** The PACC is an all age/family environment, foul language or yelling at other patrons or staff will not be tolerated
- Lockers are for daily use only, you must remove items each day unless purchasing a locker rental.
- Please leave valuables locked in your car, or locked in a locker. The PACC is not responsible for lost/stolen items.
- Behavior that adversely affects patrons or staff will be handled at the discretion of the PACC staff and could be cause for suspension or termination of membership or guest privileges. This may include *but is not limited to:* fighting, pushing, yelling, disrespecting PACC staff or foul/abusive language.
- No smoking or vaping allowed on PACC premises. This includes outside areas on PACC premises.
- To ensure a safe and welcoming environment for all members, using the premises for sleeping or overnight stays is strictly prohibited.
- **Service Animals:** We welcome Service Animals. Emotional support or comfort animals are not service animals. Only trained service animals are covered under the ADA and Minnesota Human Rights Act. Impersonating a Service Animal is punishable by fines and jail time under Minnesota statute 609.226.

## Age Restrictions and Policies:

- Children must be 13 years or older to be at the PACC without adult supervision and to use fitness equipment.
- Children 13+ must be picked up before the building closes. Members age 16+ may purchase a 24/7 access fob.
  - Exceptions include kids in direct supervision of PACC staffed activities, camps or programs.
- Children 10-12 years old can be in the facility without direct supervision, **but an adult 18+ MUST be in attendance with them AND present in the facility.**
  - Areas they may use are limited to the Fieldhouse, Back Gym, Racquetball Court and they may attend open swim
  - Kids are not allowed in the Adventureland without adult supervision
- Fitness Areas: Children under 13 are not allowed in fitness areas at any time, *regardless of adult supervision.*
- Adventureland: Children 12 and under ONLY are allowed to play in/on the Adventureland equipment and MUST be supervised by an adult 18+ who must remain in the Adventureland with the child(ren) at all times.
- Aquatics: Children 10-12 may attend open swim but **MUST have an adult 18+ present in the facility.** Children under age 10 must have an adult present in the locker room areas and on the pool deck at all times.
- **\*Children under the age of 13 are not allowed in the Sauna or Whirlpool at any time, regardless of adult supervision.** \*Per the American Academy of Pediatrics.
  - All patrons should respect PACC lifeguards when they are enforcing policies or disciplining children/patrons regarding safety policies

**All age restrictions and policies at the PACC are made with the utmost regard for your child's protection and safety.
